**NOTIFICATION**

(1) In exercise of the power conferred by sub-section (a) of section 4A of the West Bengal Agricultural Produce Marketing (Regulation) Act, 1972 (the West Bengal Act XXXV of 1972 and hereinafter referred to as the 'said Act'), the Governor is pleased to alter the limits of the market area of Paschim Medinipur Zilla Regulated Market Committee by excluding thereof the area comprised in the district of Jhargram which shall constitute a separate market area for the district of Jhargram.

(2) In exercise of the power conferred by sub-section (2) of section 5 read with sub-section (1) of the said section of the said Act, the Governor is pleased to specify the name of the market committee for the market area for the district of Jhargram as Jhargram Zilla Regulated Market Committee.

(3) In exercise of the power conferred by sub-section (1) of section 4 of the said Act, the Governor is pleased to declare that the enclosures, buildings or locality earlier declared as the Principal Market Yard and Sub Market Yards of the Paschim Medinipur Zilla Regulated Market Committee which are situated within the market area of the newly constituted Jhargram Zilla Regulated Market Committee shall now be declared as the Principal Market Yard and Sub Market Yards of the Jhargram Zilla Regulated Market Committee as per schedule appended to this Notification.

(4) In exercise of the power conferred by section 36B of the said Act, the Governor is pleased to allocate the unexpended balance and other movable properties and liabilities of the Paschim Medinipur Zilla Regulated Market Committee between the Paschim Medinipur Zilla Regulated Market Committee and the newly constituted Jhargram Zilla Regulated Market Committee in proportion to the total land area of the two districts of Paschim Medinipur and Jhargram respectively.

Objections in terms of *Explanation* to section 4A of the said Act, if any, shall be received by the State Government within a specified period of six weeks from the date of this Notification.
